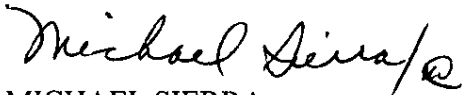

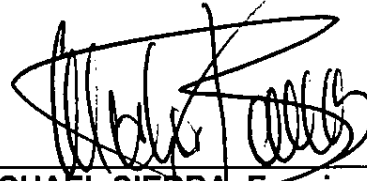

ARTICLE V- BUSINESS PURPOSE

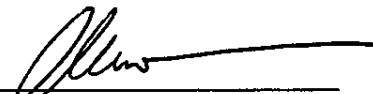
The primary business purpose of this Company is real estate investments, in addition to any other purposes permitted under Florida law.
