**ARTICLES OF ORGANIZATION FOR  
PRESIDENTIAL LUXURY AUTO RENTALS, LLC.  
A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute, Section 608.401 et. seq., entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company:

1. **NAME.** The name of this company shall be **PRESIDENTIAL LUXURY AUTO RENTALS, LLC.**
2. **ADDRESS OF COMPANY.** The mailing and street address of the principal office of the Company is **3201 South Federal Highway, Delray Beach, Florida 33483.**


