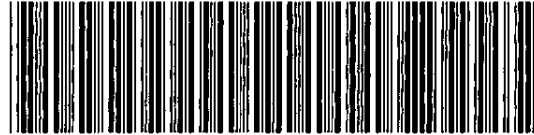

ARTICLES OF ORGANIZATION

OF

VEYNOVICH PROPERTIES, LLC

ARTICLE I - NAME

THE NAME OF THIS Limited Liability Company shall be **VEYNOVICH PROPERTIES, LLC.**

ARTICLE II - ADDRESS




