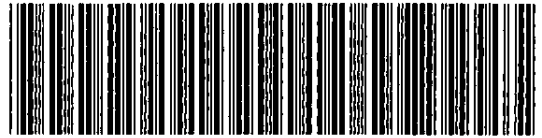

The name of this limited liability company is **JT SAPPHIRE'S, LLC**.


