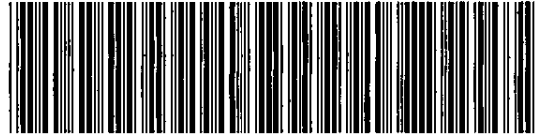

The name of the Limited Liability Company shall be: LEED HAULING, LLC.

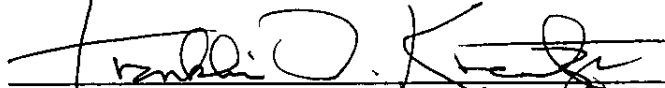
