
ARTICLE VI - MANAGEMENT

ARTICLE VII - LIMITATION ON AUTHORITY

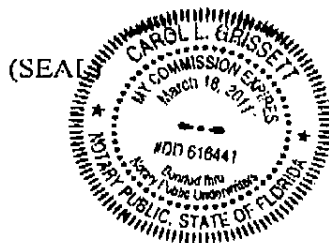
Pursuant to Section 608.4235 of the Florida Limited Liability Company Act, no member shall be an agent of the Company solely by virtue of being a member.



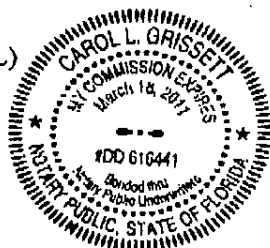
