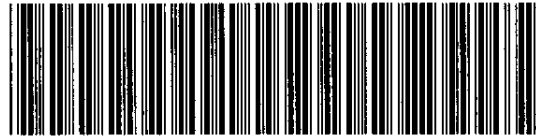

The members of this limited liability company may admit additional members with the written consent of each member.


ARTICLE VIII.
