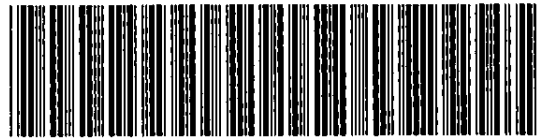

Principal Office

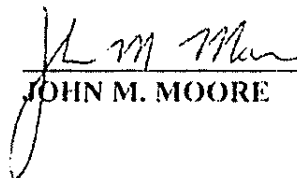
