ARTICLES OF ORGANIZATION OF IDMJI PROPERTIES, LLC

The undersigned, being a duly authorized representative of the members, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopts the following Articles of Organization:

ARTICLE I

NAME

The name of the limited liability company is IDMJI PROPERTIES, LLC ("the "Company").

ARTICLE II

<u>ADDRESS</u>

The principal office and mailing address of the Company is: 085 Levender. Circle, Weston, Florida 38327.

ARTICLE III

REGISTERED AGENT AND OFFICE

The Company designates 2999 N.E. 191st Street, Concorde Centre II, PH-8, Aventura, Florida 83180 as the street address of the initial registered office of the Company and names Oscar Grisales-Racini, Esq. as the Company's initial registered agent at that address to accept service of process within this state.

ARTICLE IV

DURATION AND CONTINUATION

The period of the Company's duration shall commence with the filing of these Articles of Organization with the Secretary of State, and shall continue perpetually, unless terminated (i) in accordance with the Company's Operating Agreement.

ARTICLE V

PURPOSE

The sole purpose for which the Company is being formed is to engage in the holding and ownership of a real estate property beneficially owned by an IRC Section 501(e)(3) Tex-Exempt Organization, and any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE VI

MANAGEMENT

The Company shall be conducted, carried on, and managed by the manager(s) and is, therefore, a manager-managed Company. The manager(s) shall also have the rights and responsibilities described in the Operating Agreement of the Company, if applicable. The manager(s) shall serve in such capacity until their successor(s) are duly elected and qualified.

ARTICLE VII

ARTICLE VIII

INITIAL AND SOLE MEMBER

The maximum number of ownership units which the Company is authorized to have cutstanding is one hundred (100), all of which shall be identical units, and each of which shall represent the ownership of that percentage of the total units outstanding at any time as is the equivalent of the ratio in which one (1) is the numerator and the total units outstanding is the denominator. The Initial and Sole Member of the Company shall be Iglesia de Dios Ministerial de Jesucristo Internacional, Inc., a Florida not-for-profit corporation.
