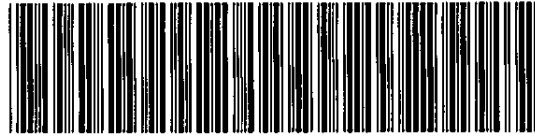

The undersigned being a Managing Member of Genicon Funding, LLC, a Florida limited liability company, (the "Company"), in accordance with the provisions of Chapter 608, Florida Statutes, hereby amends its Articles of Organization as set forth below:

1. The name of the Company is Genicon Funding, LLC.
2. The Articles of Organization for the Company were filed with the Florida Department of State on March 12, 2008, effective March 6, 2008 and assigned Document Number L08000025883.
3. Article I of the Company's Articles of Organization is hereby deleted in its entirety and the following is substituted therefor:

"ARTICLE I - Name:

"The name of the Limited Liability Company is: Genicon Funding I, LLC."

4. These Articles of Amendment shall be effective upon filing with the Florida Department of State.
5. Except as expressly provided herein, all of the terms and provisions of the Articles of Organization shall remain in full force and effect and are hereby ratified and confirmed.
