**ARTICLES OF ORGANIZATION
OF
DESIGN STYLES, PLLC**

The undersigned, acting as an authorized representative of the initial members of the above captioned Professional Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 608, *Florida Statutes*, and the Florida Professional Service Corporation and Limited Liability Company Act, Chapter 621, *Florida Statutes*, adopts the following Articles of Organization:

**ARTICLE I
