ARTICLE III - DURATION





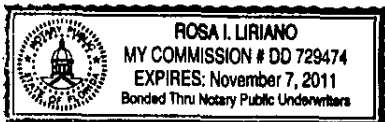
