## ARTICLES OF ORGANIZATION TAMPA BAY WEIGHT LOSS CENTER, LLC

- OSMA JANOON ON THE OR Name. The name of this limited liability company is TAMPA BAY WEIGHT LOSS CENTER, LLC, a Florida limited liability company (the "Company").
