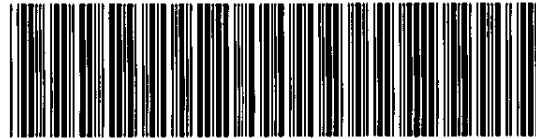

The undersigned hereby enter into these Articles of Organization of a Limited Liability Company, by and between KIMBERLY R. REGO, and pursuant to Chapter 608, Florida Statutes, hereby organize TREASURE COAST TROPICAL SMOOTHIE MARKETING, LLC, and further agree:

ARTICLE I

The name of the Limited Liability Company is TREASURE COAST TROPICAL SMOOTHIE MARKETING, LLC.

ARTICLE II

These Articles of Organization shall be effective upon filing with the Florida Department of State.

ARTICLE III

The Limited Liability Company is organized for the purposes as follows:

- (a) To engage generally in the business of advertising, promotions and marketing;
- (b) To perform fully any agreement with any member of the Limited Liability Company;
- (c) To have all of the powers of Limited Liability Companies generally organized and existing under Chapter 608, Florida Statutes or such powers as shall hereafter be conferred upon such companies by the laws of the State of Florida.

ARTICLE IV

The Limited Liability Company may have more than one place of business but its registered office shall be 2827 NE Cold Spring Drive, Jensen Beach, FL 34957. Its initial registered agent shall be Kimberly R. Rego at 2827 NE Cold Spring Drive, Jensen Beach, FL 34957. The principal and mailing address is 2827 NE Cold Spring Drive, Jensen Beach, FL 34957.

ARTICLE V

Additional members may be admitted upon such terms, conditions, agreements and understandings as shall be agreed upon by the members including contributions to capital. Members shall consist of all franchisees of Tropical Smoothie Corporation within the geographical area often referred to as The Treasure Coast and include Martin, St. Lucie, Okeechobee and Indian River Counties.

ARTICLE VI

Upon the death, retirement, resignation, bankruptcy, expulsion or dissolution of a member which is a corporate association or trust, or the occurrence of any other event which terminates the continued membership of a member in the Company, the Company shall continue business unless a majority in interest of all of the remaining members determine, in writing, to terminate the Company, in which event Articles of Dissolution shall be prepared and filed.

ARTICLE VII

The Company shall be managed by a manager or managers which shall be selected by the members on an annual basis and which manager or managers shall continue in such capacity until their successor(s) are duly elected and qualified and assume their duties. The initial manager who shall serve until the first annual meeting of or until his successor is elected and qualified is:




