**ARTICLES OF ORGANIZATION
OF
EHR PRIVATE EQUITY INVESTMENTS, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be EHR Private Equity Investments, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be: 5000 Sawgrass Village Circle, Suite 2, Ponte Vedra Beach, Florida 32082.

ARTICLE II

DURATION

ARTICLE VI**ADMISSION AND WITHDRAWAL OF MEMBERS**

No additional members shall be admitted to the Company except with the unanimous written consent of the members of the Company.


ARTICLE VII**TERMINATION OF EXISTENCE**


