The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 808, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.




