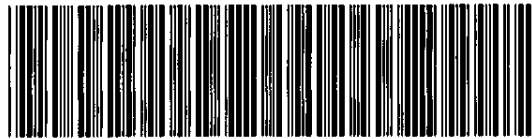

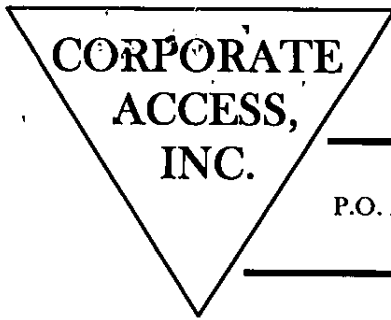

ARTICLE IV - MANAGEMENT


