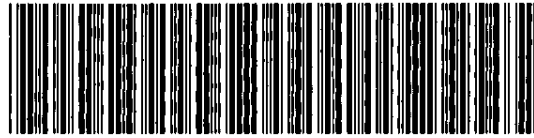

3. Principal office and Mailing address: 1907 NE 4th Street, Unit 2, Deerfield Beach, FL 33441.

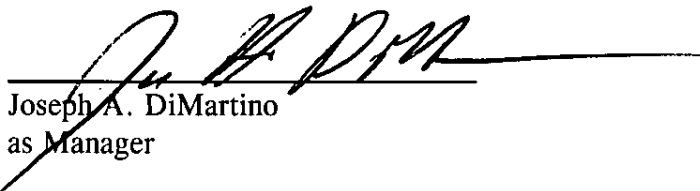

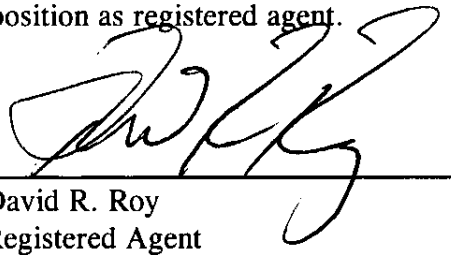
**CERTIFICATE OF DESIGNATION OF
