ARTICLES OF ORGANIZATION OF THE NEW YOU OF TAMPA BAY, LLC

- 1. Name. The name of this limited liability company is **THE NEW YOU OF TAMPA BAY, LLC**, a Florida limited liability company (the "Company").
- 2. <u>Duration</u>. The Company shall be effective on <u>March 13, 2008</u> and shall thereafter have perpetual existence.
