The Company's business and purpose shall consist solely of the following:

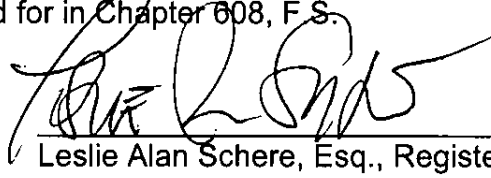

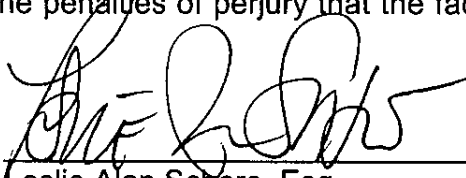
