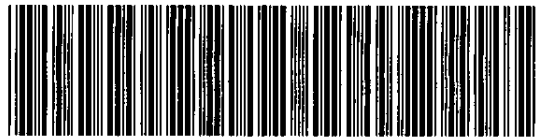



The undersigned, a member of Cayman Sales, LLC and pursuant to section 608.411 of the Florida Limited Liability Company Act, adopts these First Articles of Amendment to Articles of Organization:

FIRST: The name of the limited liability company (the "Company") is:

FOURTH: The following provision shall be added as a new Article V to the Articles of Organization:


ARTICLE V. MANAGEMENT OF COMPANY
