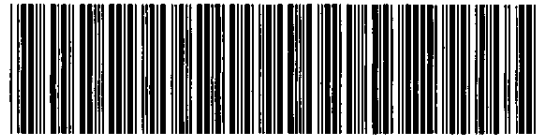

The undersigned, for the purpose of forming a limited liability company
under the laws of the State of Florida, does hereby adopt the following articles of
organization:

ARTICLE I: NAME OF LIMITED LIABILITY COMPANY

The name of the limited liability company is
PLACY'S, LLC.

ARTICLE II: TERM OF EXISTENCE

The limited liability company shall have a perpetual existence.

ARTICLE III: GENERAL NATURE OF BUSINESS

The general purposes for which the limited liability company is organized are:

1. To engage in the business of providing wholesale and retail sales and services to the general public.
2. To transact any other lawful business for which limited liability companies may be organized under the laws of the State of Florida.
3. To do such other things as are incidental to the foregoing or necessary or desirable to accomplish the foregoing.

ARTICLE VII: PREEMPTIVE RIGHTS


Each member of the limited liability company shall have the right to purchase, subscribe for, or receive a right or rights to purchase or subscribe for, a pro rata portion of


