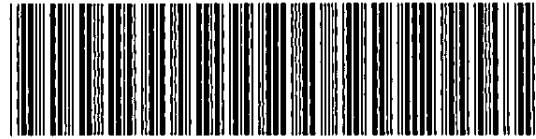

Admission of Additional Members


The right of the remaining partners to admit additional members and the terms and conditions of the admissions are as follows:


