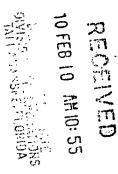

## ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF

### EYE PHYSICIANS OF CENTRAL FLORIDA, P.L.C.

The undersigned being one of the members of EYE PHYSICIANS OF CENTRAL FLORIDA, P.L.C., a Florida Professional limited liability company (the "Company"), in accordance with the provisions of Chapters 608 and 621, Florida Statutes, hereby amends its Articles of Organization as set forth below:

- 1. The name of the Company is EYE PHYSICIANS OF CENTRAL FLORIDA, P.L.C.
- 2. The Articles of Organization for the Company were filed with the Florida Department of State on March 24, 2008.
- 3. Article V of the Company's Articles of Organization is hereby deleted in its entirety and the following is substituted therefor:
