**ARTICLES OF ORGANIZATION
OF

The undersigned member hereby executes these Articles of Organization ("Articles") for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this limited liability company (the "Company") shall be:

Tampa Bay Capital Group, LLC

ARTICLE II

Principal Office and Mailing Address

The address of the principal office and the mailing address of the Company shall be 5401 South Dale Mabry, Highway, Tampa, FL 33611.

ARTICLE III

Registered Office and Registered Agent

The initial registered office of the Company shall be located at 5401 South Dale Mabry, Highway, Tampa, FL 33611 and the initial registered agent of the Company at such office shall be Mark J. Rubio. The Company shall have the right to change such registered office and such registered agent from time to time, as provided by law.


ARTICLE V**Operating Agreement**
