ARTICLES OF ORGANIZATION

OF

ALLANTON LANDING, L.L.C.

The undersigned, being authorized to execute and file these Articles on behalf of the members for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, does hereby certify and adopt these Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be "ALLANTON LANDING, L.L.C." ("Company").

ARTICLE H - ADDRESS

The mailing address and street address of the principal office of the Company shall be 2200 Nelson Street, Panama City, Florida 32402-0960.

ARTICLE III - DURATION

ARTICLE V - CAPITAL CONTRIBUTIONS
