ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the laws of Florida, hereby adopts the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be NCR Myrtle Beach, LLC (the "Company").

IN WITNESS WHEREOF, the undersigned, an authorized representative of the members, has executed these Articles of Organization on the 24th day of March 2008.




