ARTICLES OF ORGANIZATION

OF

BIG POND PRODUCTS, LLC

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Limited Liability Company Act" for for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

1. NAME.

The name of the Limited Liability Company is BIG POND PRODUCTS, LLC (hereinafter referred to as the "Company").

Additional contributions, if any, will be made as provided in the Operating Agreement.

8. CONTINUITY OF BUSINESS.

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company, the business of the Company shall be continued and the Company shall not be dissolved without the prior written

consent of all the remaining Members of the Company.

The Company shall be member managed.


10. INDEMNIFICATION.
