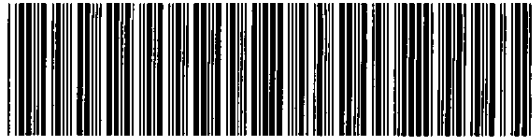

ARTICLES OF ORGANIZATION

OF

KOUMANDRAKIS, LLC

ARTICLE I

NAME, PRINCIPAL ADDRESS, AND MAILING ADDRESS

The name of this limited liability company is Koumandrakis, LLC and the initial principal address and mailing address of the limited liability company is 7820-B Causeway Blvd., Tampa, Florida 33619.

ARTICLE II

NATURE OF BUSINESS AND POWERS

The general nature of the business transacted by this limited liability company is to engage in any and all business permitted under the laws of the State of Florida. The members from time to time may move the registered office and/or the principal office to any other address in the State of Florida.



ARTICLE V MANAGEMENT


