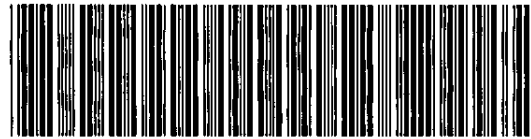



ARTICLE VI




