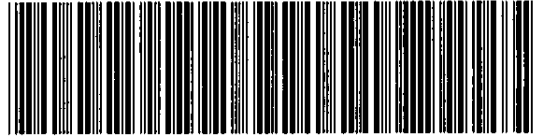



INFIELD FLY RULE LLC**


