**ARTICLES OF ORGANIZATION
CA LINDMAN OF SOUTH FLORIDA, LLC**

**ARTICLE I
ORGANIZER**

I, Robert G. Pusheck, whose post office address is 10411 Guilford Road, Jessup, Maryland 20794, being a natural person at least eighteen (18) years old and a person authorized to execute and file these Articles, do hereby form a limited liability company pursuant to the Florida Limited Liability Company Act.

**ARTICLE II
NAME**

These Articles shall be effective on March 25, 2008.

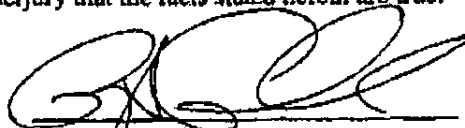
