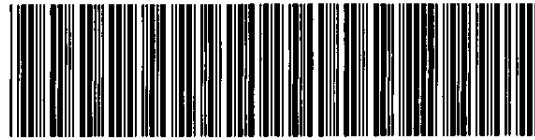

Pursuant to the Florida Limited Liability Company Act, the undersigned hereby adopts the following Articles of Organization.

**ARTICLE I**

The name of the limited liability company is DIETZ, LLC (the "Limited Liability Company"), and the mailing address and principal office address of the organization shall be 3299 Salinger Way, Tallahassee, Florida 32311.





