GIOVANINI, M.D., a natural person competent to contract and a member of GULF-KIDS, LLC, hereby presents these Articles of Organization as the Articles of Organization of GULF-KIDS, LLC, a limited liability company formed under the provisions of Chapter 608, Florida Statutes.

ARTICLE I - NAME

The name of the limited liability company is:

GULF-KIDS, LLC

This limited liability company is referred to in these articles of organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

ARTICLE III - PURPOSES AND POWERS

ARTICLE V - REGISTERED OFFICE AND AGENT

New members shall be admitted in accordance with the terms of the Operating Agreement for the Company.


ARTICLE VIII - RESTRICTION ON MEMBERSHIP
