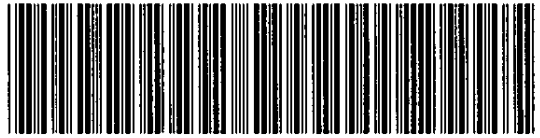

ARTICLES OF ORGANIZATION

AAM Properties of Central Florida, LLC

A LIMITED LIABILITY COMPANY

1. **Name.** The name of the limited liability company is AAM Properties of Central Florida, LLC.

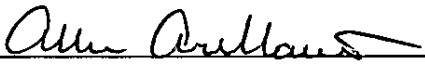
