**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION OF
VETERINARY SPECIALTY AND EMERGENCY CENTER OF KANSAS CITY, LLC**

These Amended and Restated Articles of Organization of Veterinary Specialty and Emergency Center of Kansas City, LLC (the "Company") are made as of this 13th day of September, 2011. The original Articles of Organization were filed with the Department of State of Florida on April 1, 2008, under document number L08000033329. These Amended and Restated Articles of Organization have been duly executed and are being filed in accordance with Section 608.411 of the Florida Limited Liability Company Act. These Amended and Restated Articles of Organization are intended to amend, restate, and replace the original Articles of Organization in their entirety.

**Article I
Name**

The name of the Company is Veterinary Specialty and Emergency Center of Kansas City, LLC.

ARTICLE II

Principal Office Street and Mailing Address

The street address and the mailing address of the principal office of the Company is 3000 Busch Lake Boulevard, Tampa, FL 33614.

ARTICLE III

Registered Office and Agent

ARTICLE IV

Qualification

Licensed veterinarians employed by the Company when practicing in the State of Missouri will not be subject to the direction of anyone not licensed to practice veterinary medicine in the State of Missouri in making veterinary medical decisions or judgments.
