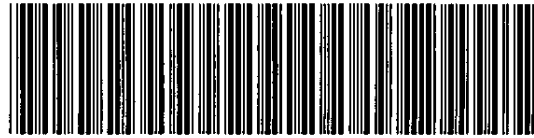

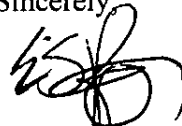

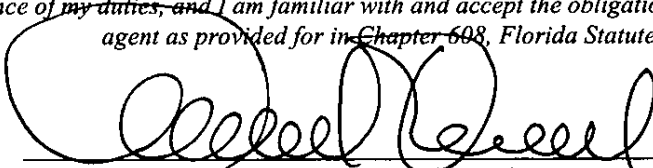

#### Article VI

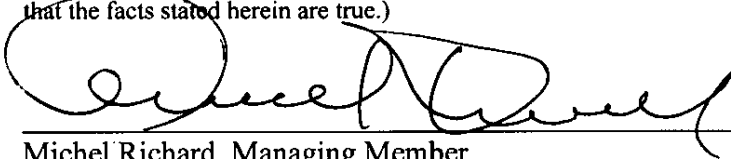
