# ARTICLES OF ORGANIZATION

### OF

# ECHO WOODS HOUSING LLC

The initial registered agent for the Company shall be Steven Kirk, and the street address of the Company's initial registered office is 19308 SW 380<sup>th</sup> Street, Florida City, Florida, 33034.

### **ARTICLE VIII - Amendments:**

The Company reserves the right to amend any provision of these Articles of Organization, which amendment shall only be effectuated in accordance with the terms of the Operating Agreement of the Company.

### **ARTICLE IX - Indemnification:**
