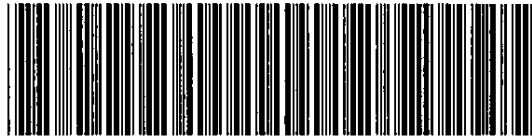

Pursuant to Section 608.0411, Florida Statutes, **JACKSONVILLE JETPORT LLC**, a Florida limited liability company (the "Company"), hereby certifies that the following Second Amended and Restated Articles were duly adopted on September 19, 2008, in restatement and substitution for the prior Amended and Restated Articles of Organization of the Company (the "Existing Amended and Restated Articles of Organization").

Accordingly, the existing Amended and Restated Articles of Organization are hereby restated in their entirety to read as follows:

**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF

In accordance with the provisions of the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, (the "Act") the undersigned, sole organizer of a Florida limited liability company, and an authorized representative of a Member of the Company, hereby certifies as follows:

ARTICLE I -- NAME

The name of the limited liability company is **JACKSONVILLE JETPORT LLC** (the "Company").

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the Company in the State of Florida is 13365 Aeronautical Circle, Jacksonville, FL 32221.

ARTICLE III -- REGISTERED AGENT & OFFICE

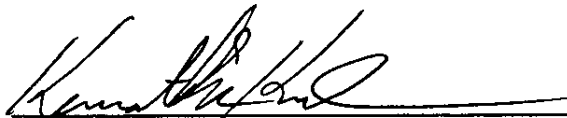
The name and address of the Company's registered agent is Kenneth M. Kirschner, 300A Wharfside Way, Jacksonville, Florida, 32207. The Company may designate another registered agent at any time.

ARTICLE V – MANAGING MEMBER

The initial Managing Member of the Company shall be AIR-1 FBO, LLC, the Managing Member of which is AVIATION PARTNERS, LLC, the Managing Members of which are Jay C. Demetree, Jr. and Robert L. Stein.

The management, operation and ownership of the Company shall be governed by a Limited Liability Company Operating Agreement, the power to adopt, alter amend or repeal which shall be vested in the Members of the Company.
