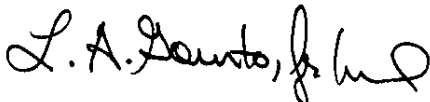

ARTICLES OF ORGANIZATION
of

ARTICLE 1
NAME

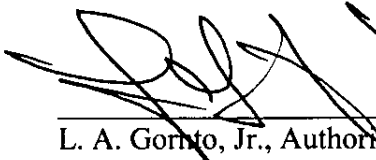

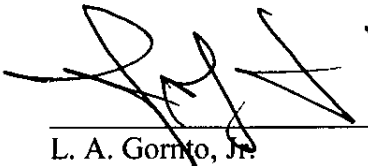
