## ARTICLES OF ORGANIZATION OF THORNTON & ASSOCIATES, LLC

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles Organization.

#### ARTICLE I

The name of the Limited Liability Company shall be Thornton & Associates, LLC.

#### ARTICLE II ADDRESS
