#### ARTICLES OF ORGANIZATION

#### ARTICLE I

#### <u>Name</u>

#### ARTICLE IV

#### Purposes

The limited liability company may engage in the transaction of any or all lawful business for which limited liability companies may be formed under the laws of the State of Florida.

#### ARTICLE V

#### General Powers

- Indemnify a Member or any other person to the same extent as a corporation may (j) indemnify any of the directors, officers, employees, or agents of the corporation against expenses actually and reasonably incurred by him or it in connection with the defense of an action, suit, or proceeding, whether civil or criminal, in which he or it is made a party.
  - Cease its activities and surrender this Certificate of Organization. (k)
- (l) purposes for which the limited liability company is organized.
- Have and exercise all powers necessary or convenient to effect any or start the start of the which the limited liability company is organized.

  Transact any lawful business which the Members find to be in aid of governmentable of the start (m) policy.
- (n) Pay pensions and establish pension plans, profit-sharing plans and other incentive plans for any or all of its employees.

- (o) Be a promoter, incorporator, general partner, limited partner, Member, associate, or manager of any corporation, partnership, limited partnership, limited liability company, joint venture, trust, or other enterprise.

#### Registered Office and Registered Agent
