- 7. The several clauses contained in this statement of the general nature of the business or businesses to be transacted shall be constructed as post purposes and powers of this limited liability company, and statements contained in each clause shall, except as otherwise expressed, be in the way limited or restricted by reference to or inference from the terms of any other clause. They shall be regarded as independent purposes and powers.
