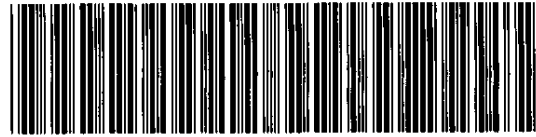

ARTICLE I

NAME

The name of this limited liability company is SRX5 LLC, referred to in these Articles of Organization as the "Company."

MANAGEMENT

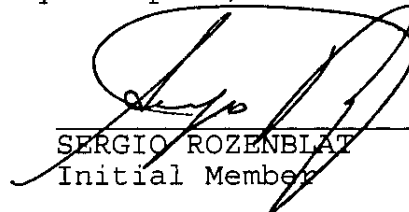
The management of the Company is reserved to the members of the Company.
