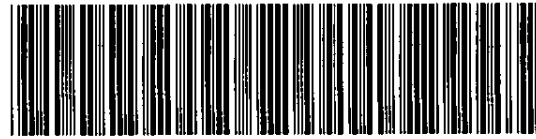

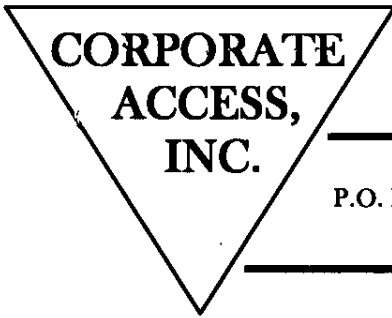

FIRST: This Amended Restated Articles of Organization amends and restates the Articles of Organization of Timson & Dearman, LLC.

SECOND: The original Articles of Organization of Timson & Dearman, LLC were filed with the Florida Department of State on April 7, 2008, and assigned Document Number L08000035237.

THIRD: The Articles of Organization of Timson & Dearman, LLC are hereby amended and restated by deleting the existing Articles of Organization of Timson & Dearman, LLC in its entirety and replacing it with the following:

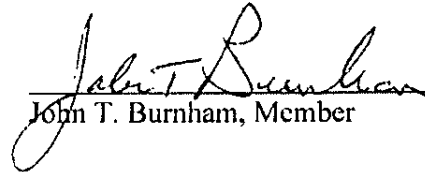
