ARTICLES OF ORGANIZATION TOWLES CLUB K-9 RESORT, LLC

RR BR 3.21 The undersigned, for the purpose of forming a limited liability company under the Floridge Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be TOWLES CLUB K-9 RESORT, LLC ("Company").

ARTICLE II - ADDRESS

The street address of the initial principal office of the Company is 3900 Taylor Road, Punta Gorda, FL 33950, and the initial mailing address P.O. Box 510850, Punta Gorda, FL 33951-0850.
