MEMBERSHIP



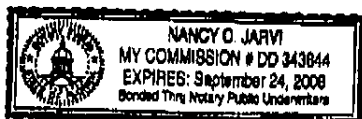
