Amidst renovation setbacks, it was mutually decided that Legacy Photography Studios, LLC would not open for business nor would managing members Gregory W. Leary and Debra French be partners in current LLC or any future business ventures.

Debra French continued to stay at principal address starting a separate business venture under the fictitious name The Plantation (G05190900248). Greg Leary is currently employed as Broward County school teacher of photography.

No members remained in the management of Legacy Photography Studios, LLC, and former members in no way wished to continue in business together. Therefore, the business never came to fruition. According to statute 608.441(4), the LLC was thereby dissolved.
