ARTICLES OF ORGANIZATION

This Company will be a **manager-managed** company managed by one or more managers in accordance with and subject to the requirements of the Act and the Operating Agreement of this Company.

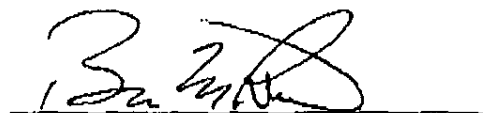

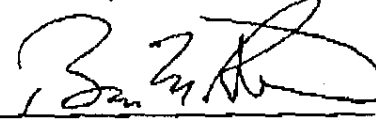

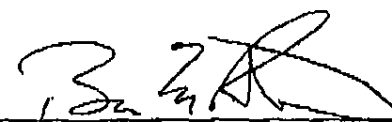
