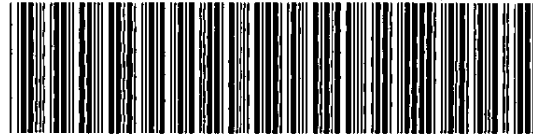

## **ARTICLES OF ORGANIZATION OF BRASHEAR, MARSH, KURDZIEL & MCCARTY, PL**

The undersigned Members adopt the following Articles of Organization pursuant to the provisions of the Florida Limited Liability Company Act and the Professional Services Corporation and Limited Liability Company Act (the "Acts").

### **ARTICLE I NAME OF COMPANY**



PURPOSE OF COMPANY






